RESOLUTION NO. 16- 23**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OJAI,  
CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE A  
CONTRACT IN AN AMOUNT NOT TO EXCEED \$291,701.50 FOR THE  
SARZOTTI PARK PICNIC AND BARBECUE AREA SHELTER  
PROJECT (PROJECT PW 2016-01)**

**WHEREAS**, the City submitted an application for Community Development Block Grant (CDBG) fund administered through the County of Ventura for the renovation of the picnic area at Sarzotti Park; and

**WHEREAS**, the City was awarded \$80,904 in CDBG funds for the project; and

**WHEREAS**, a budget of \$350,000 is hereby allocated from the Capital Improvement Program, funded by \$80,904 in CDBG funds, up to \$95,000 from the Ojai Civic Association donation, \$25,000 from the Recreation Fund, the remainder from the AB 939 Fund available for the Project, with contingency provided by Fund 31; and

**WHEREAS**, taking into account the federal and Ventura County requirement, imposed on this project because it is partially funded by a CDBG grant, that the City adjust all bids received for the project from contractors certified by the County under the HUD Section 3 Plan providing preference for contractors who provide low and very low income persons employment opportunities (12 U.S.C. § 1701u), reducing bids from such certified contractors by \$21,000, the lowest bidder for this project was California Electric Company, with an effective bid amount of \$270,701.50.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OJAI,  
CALIFORNIA, DOES HEREBY RESOLVE AND ORDER, AS FOLLOWS:**

SECTION 1. Authorizes the Interim City Manager to award and execute a contract in an amount not to exceed \$291,701.50 for the Sarzotti Park Picnic and Barbecue Area Shelter Project with California Electric Company; and

SECTION 2. Authorize the Public Works Director to approve up to 15% in change orders.


