RESOLUTION NO. 20-18

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OJAI TEMPORARILY SUSPENDING LATE FEES AND PENALTIES PERTAINING TO SECTION 8-1.418 OF THE OJAI MUNICIPAL CODE CONCERNING PAYMENT OF UNIFORM TRANSIENT OCCUPANCY TAX IN ORDER TO WAIVE LATE FEES AND PENALTIES FOR PAYMENTS OF TAXES DUE MARCH 31 2020 AND APRIL 30 2020

WHEREAS, conditions of extreme peril to the safety of persons have arisen and continue to exist within the City of Ojai as the result of conditions surrounding the novel coronavirus COVID-19 pandemic; and

WHEREAS, the Governor has declared a State Health Emergency in response to the novel coronavirus COVID-19 pandemic; and

WHEREAS, on March 13, 2020, the President of the United States declared a national emergency as a result of COVID-19; and

WHEREAS, the City Manager, acting as the Director of Emergency Services did proclaim the existence of a local emergency within the City on the 13th day of March 2020, and issued Executive Orders to protect public health and safety; and

WHEREAS, the City Council ratified the proclamation of a local emergency on March 13, 2020 by adoption of Resolution No. 20-11; and

WHEREAS, the City Council finds that suspending enforcement of certain provisions of the Municipal Code regarding collecting the transient occupancy tax from hotels in the City is in the best interest of the public's health, safety, and welfare; and

WHEREAS, this Resolution is temporary in nature and is intended to provide temporary financial relief to hotels within the City of Ojai during, and immediately following, the City's response to the COVID-19 pandemic outbreak; and

WHEREAS, this Resolution is adopted pursuant to the City's police powers and those powers afforded to the City in time of national, state, county, and local emergency during an unprecedented health pandemic, such powers being afforded by the State Constitution, State Law, and Chapter 3.1-06 of the Ojai Municipal Code to protect the peace, health, and safety of the public; and

WHEREAS, the City Council of the City of Ojai finds that this Resolution is necessary for the preservation of the public peace, health, and safety of residents living within the City and finds such urgency to approve this Resolution immediately based on the facts described herein and detailed in the staff report.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OJAI CALIFORNIA HEREBY RESOLVE AS FOLLOWS:

SECTION 1. Recitals. All of the foregoing recitals are true and correct.

SECTION 2. Suspension of Late Fees and Penalties. Late fees and penalties pertaining to section 8-1.418 of the Ojai Municipal Code, et seq. requiring that each operator remit the full amount of the transient occupancy tax collected to the Tax Collector are waived, on the terms and conditions specified in this Resolution, solely for the payment of transient occupancy taxes collected during the month of February 2020 and due to the Tax Collector on March 31, 2020 and the payment of transient occupancy taxes collected during the month of March 2020 and due to the Tax Collector on April 30, 2020.

SECTION 3. Taxes Remain Owed. All transient occupancy taxes collected during the month of February 2020 and due to be returned to the Tax Collector on March 31, 2020 and all transient occupancy taxes collected during the month of March 2020 and due to be returned to the Tax Collector on April 30, 2020 are still due and payable to the Tax Collector on or before May 30, 2020.

SECTION 4. Duty to Collect. Nothing in this Resolution shall relieve an operator from collecting the amounts required to be collected from transients, as specified in Section 8-1.412 of the City of Ojai Municipal Code. This Resolution also does not relieve any operator from its obligation to remit to the City the transient occupancy tax collected.

SECTION 5. Duty to Report. Each operator that collects, or has collected, the uniform transient occupancy tax shall continue to be required to comply with Section 8-1.417 of the City of Ojai Municipal Code requiring an operator to report to the City's Tax Collector the total rents charged and received and the amount of tax collected for transient occupancies.

SECTION 6. Enforcement. Any failure by an operator to pay transient occupancy taxes to the Tax Collector due for periods of time other than the payments due March 31, 2020 and April 30, 2020 is unlawful and such operator shall be subject to all lawful remedies available to the City, including, but not limited, to the remedies in Ojai Municipal Code section 8-1.439 and 8-1.440. Any failure by an operator to pay transient occupancy taxes to the Tax Collector due for February 2020 and March 2020 on or before May 30, 2020 is unlawful and such operator shall be subject to



all lawful remedies available to the City, including, but not limited, to the remedies in Ojai Municipal Code section 8-1.439 and 8-1.440.

SECTION 7. Certification. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.


