RESOLUTION NO. 20-40

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OJAI, CALIFORNIA, CONFIRMING THE DIAGRAM AND ASSESSMENTS FOR LANDSCAPING AND LIGHTING DISTRICT NO. 3 AND ORDERING THE WORK AND THE LEVY OF ASSESSMENTS AS SET FORTH THEREIN FOR THE PERIOD BEGINNING JULY 1, 2020 AND ENDING JUNE 30, 2021.

WHEREAS, pursuant to the Landscaping and Lighting Act of 1972 (the “Assessment Law”), on January 28, 2020 the City Council adopted Resolution No. 20-02 directing the City Engineer to prepare and file an annual report for the maintenance of street lighting, curb, gutter, sidewalk and street tree system improvements to be maintained, including light poles, lighting fixtures, lighting standards, light bulbs, lenses, covers and screens and other miscellaneous street lighting appliances, curb, gutter, and sidewalk and street tree safety repair as shown and included on the Landscaping and Lighting District No. 3 (the “District”) Diagram and Plan No. L-2-20/21; and

WHEREAS, on April 28, 2020 the City Council adopted Resolution No. 20-20 approving the Engineer’s Report entitled Landscaping and Lighting District No. 3 Engineer’s Report dated April 23, 2019 (the “Report”) of the City Engineer; and

WHEREAS, on April 28, 2020 the City Council adopted Resolution No. 20-22 declaring its intention to levy and collect assessments within Landscaping and Lighting District No. 3.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OJAI DOES HEREBY RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the foregoing recitals are all true and correct.

SECTION 2. That the City Council does hereby approve, confirm and adopt the diagram and assessments for the District as set forth in the Report.

SECTION 3. That the City Council does hereby order the work and levy the assessments for the maintenance of specified improvements within the District for that period beginning July 1, 2020 and ending June 30, 2021. Reference is made to the Report for a full and detailed description of the public facilities to be maintained in connection with the District, of the boundaries of the District, and of the amount of the assessments upon assessable lots and parcels of land within the District.


SECTION 4. That the City Clerk is hereby ordered to transmit or cause to be transmitted to the Auditor of the County of Ventura said assessments and diagram and plan upon which such levy is based; and the County Tax Collector of said County is hereby designated, requested, empowered, authorized, instructed and directed to enter said assessments upon the County Assessment roll and collect said assessments on behalf of the City of Ojai.


